Chancellor Christine Holt

Sherri Ford confirmed FY25-26 tuition and fee increases were just under 10%. She also highlighted the need for repairs to several facilities, including the boiler/chiller system in the Student Center, campus doors and locking mechanisms for safety concerns, and addressed the Hempstead Hall parking lot concerns. She mentioned that they may need to explore alternate resources for funds to cover these repair costs due to extensive deterioration.
