The funeral service program's accreditation allows a student to sit for the National Board Examination in all 50 states. However, some states may require additional college credits beyond UAHT's AAS in Funeral Service to obtain licensure. We recommend students check with their state's funeral licensing board for specific requirements. Obtaining a Funeral Director and Embalmer License is dependent upon the state you intend to practice.
